The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in July 2023.

Law of Georgia "on Copyright and Related Rights"

On the 3<sup>rd</sup> of July, 2023 article 15 (Copyright on Audiovisual Work); Article 18 (property rights of the author of the work); Article 21 (Reproduction of the work by individuals for personal use), etc. on Copyright and Related rights of the Law of Georgia were formed with a new reduction.

The Law, except for the first article of this law, came into force upon its publication

The First article of the Law will come into force from the 1st of September, 2023.

Law of Georgia "on Licenses and Permits"

On the 3<sup>rd</sup> of July, 2023 an amendment was made to the Law of Georgia "on Licenses and Permits" and Article 11 was supplemented to Article 21 with the following content:

"11. The issuer of the license of the work provided with paragraphs 72-725 of Article 6 of this

Law has the right to control the fulfillment of license conditions only three times during a

calendar year.

2. Article 221 (suspension of licenses for activities provided with paragraphs 72-725 of Article

6 of this Law) was supplemented to the Law.
