The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in November 2023.

### Law of Georgia "on Remuneration of Labor in Public Institutions"

On the 1st of November, 2023 an amendment was made in the Law "on remuneration of labor in public institutions" and Article 1 (Scope of Law); Article 2 (definition of terms); "Chapter IV<sup>1</sup> (Salary of an intern) etc. were formed with a new edition.

### Law of Georgia "on Entrepreneurs"

On the 1st of November, 2023 paragraph 4 with the following content was supplemented to Article 86 of the Law of Georgia "on Entrepreneurs":

"4. Legal entity under public law - pension agency (hereinafter - pension agency) is not a creditor for the purposes of this law. In respect of pension assets owned by the Participant as defined by the Law of Georgia "on Accumulated Pension", the creditor/creditors is/are the respective participant or the participant's heir/heirs. In accordance with this law, in the case of the liquidator's application, the pension agency is obliged to provide the said person with the information available in the electronic system regarding the pension contributions made by the relevant employer, also, the information obtained as a result of comparison with the data received from the legal entity under public law - revenue service included in the sphere of governance of the Ministry of Finance of Georgia, "on accumulated pension" in accordance with the law of Georgia.

- 2. Sub-paragraphs "a" "f" of paragraph 28 of Article 1 of the Law, sub-paragraph "c" of Article 34, paragraph 2 of Article 341 of the Law defined by paragraph 36 and paragraph 1 of Article 2 of this Law shall enter into force from the 3<sup>rd</sup> of January, 2024.
- 3. Sub-paragraph "c" of paragraph 6 of the first article of the Law, paragraph 7 and subparagraph ,,L" of paragraph 4 Article 8 of the Law defined by sub-paragraph ,,D" of Article 8 shall enter into force from the 1st of January.
- 4. sub-paragraph "b" of paragraph 4 of Article 15<sup>1</sup> of the Law defined by paragraph 16 of Article 1 of the Law shall come into force from the 1st of September, 2024.
- 5. Paragraph 8 of Article 3 of the Law defined by sub-paragraph "D" of paragraph 3 of Article 1 of the Law and paragraph 30 shall come into force from the 1st of January 2025.

# Law of Georgia "on State Procurement"

On the 1st of November, 2023 sub-paragraph "U" of paragraph 31 of the first article of the Law of Georgia "on State Procurement" was amended with the following redaction:

"U) on purchases related to the implementation of investment activities by a legal entity under public law - pension agency, also, on purchases related to audit firm services to carry out an independent audit of the accountancy of the specialized depository (including the case related to the specialized depository provided in Article 26, paragraph 13 of the Law of Georgia "on Accumulated Pension"), asset management company and pension agency in accordance with the law of Georgia "on Accumulated Pension" by the Pension Agency.

Paragraphs 1, 4, 6 and 7 of Article 1 and paragraphs 3 and 5 of Article 2 of the Law shall come into force from the 1st of January, 2024.

Paragraph 5 of first Article and paragraph 4 of Article 2 of the Law shall come into force from the 1st of May, 2024.
