(December 2023)

The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in December 2023.

Tax Code of Georgia

On the 13th of December, 2023 amendments were made to the Tax Code of Georgia and parts 7 and 8 of Article 80 (object of taxation); Article 81 (tax rate); Article 97 (object of taxation), etc. were formed with a new edition.

The Law came into force from the 1st of January, 2024.

The same code was amended on December 13, 2023, and parts 7 and 8 of Article 80 (object of taxation); Part 31 of Article 81 were formed with the following redaction:

"31. Taxable income received by a natural person from arranging a gaming machine salon and/or from organizing gambling games in system-electronic form is taxed at 15 percent."; Article 82, part one, subsection "Z2" was formed with the following wording:

"Z²) Income received from the mentioned activities by the gambling club, totalizator organizer;"; Article 97 (object of taxation) was established with a new edition; Article 135 (reporting period); Article 154 (the rule of withholding tax at the source of payment) were formed with a new edition.

The Law came into force from the 1st of January, 2024.

Law of Georgia "on arranging of Lotteries, Gambling and Profitable Games"

On the 13th of December, 2023 sub-paragraph "a" of paragraph 21, Article 1 of the Law of Georgia "on the organizing of Lotteries, Gambling and Profitable Games" was formed with the following redaction:

"2. Permit conditions by the permit holder for the arrangement of the gambling house, the permit holder for the arrangement of the gaming machine salon, the permit holder for the arrangement of the totalizer, the permit holder for the organization of gambling games in system-electronic form, the permit holder for the organization of games of slot machines in the system-electronic form and the permit holder for the organization of games of the totalizer in system-electronic form and fulfilling the requirements of Georgian legislation" are controlled by the electronic system of the gaming business control provided by the first paragraph of this article.

Code of Spatial Planning, Architectural and Construction Activities of Georgia

On the 13th of December, 2023 Article 1415 of the Code of Spatial Planning, Architectural and Construction Activities of Georgia (temporary rule of exemption from responsibility for non-submission of the milestone protocol during the construction of a building) was formed with a new edition.

Law of Georgia "On Enforcement Proceedings"

On the 15th of December, 2023 amendment was made to the Law of Georgia "on Enforcement Proceedings" and Article 21 (restriction of implementation of coercive enforcement measures); Article 34 (termination of enforcement), etc. were formed by a new edition.

The Law of Georgia on "registration of citizens of Georgia and foreigners living in Georgia, the procedure for issuing an identity (residence) certificate and a passport of a citizen of Georgia"

On the 15th of December, 2023 Article 2015 with the following content was supplemented to the Law of Georgia on registration of citizens of Georgia and foreigners living in Georgia, the procedure for issuing an identity (residence) certificate and a passport of a citizen of Georgia":

- 1. From the 1st of July, 2024, the valid non-electronic (not having an electronic information carrier) identity cards of Georgian citizens, which were issued before July 28, 2011, will be canceled.
- 2. The same identification data of the relevant person, which are on the Georgian citizen's identity card provided in the said paragraph, will be added to the new Georgian citizen's identity card issued in exchange for the same identity card to the holder of the Georgian citizen's identity card provided in the first paragraph of this article.

On the 15th of December, 2023 Amendments were made to the Law of Georgia "on Local Fees" and Article 5 (Local Fees); Article 123 (container fee); Article 177 (Exemption from payment of container fee) etc.were formed with a new edition.

Law of Georgia "on Public Registry"

On the 15th of December, 2023 an amendment was made to the Law of Georgia "on Public Registry" and Article 2 (definition of terms used in the law); Article 11 (rights and obligations subject to registration in the register of rights to real estate) etc.were formed with a new edition.

Paragraphs 1, 3 and 5 of Article 1 of the Law shall enter into force on the 90th day after publication.

Paragraphs 2 and 4 of the first article of the law shall come into force from September 1, 2024.

Law of Georgia "on General Education"

















On the 15th of December, 2023 an amendment was made to the Law of Georgia "on General Education" and Article 2 (definition of terms); Article 6 (general education) etc. were formed with a new redaction.

Paragraph 6 of Article 6 of the Law provided in paragraph 2 of Article 1 of the Law shall enter into force from January 1, 2025.

Law of Georgia "On copyright and related rights

On the 15th of December, 2023 Article 4 of the Law of Georgia "on Copyright and Related Rights" (definition of the terms used in the law); "Article 231 (permitted use of a printed work protected by copyright and related rights for the benefit of a person with impaired ability to read a printed work) etc. were formed with a new edition.

Code of Spatial Planning, Architectural and Construction Activities of Georgia

On the 15th of December, 2023 Article 1418 of the Code of Spatial Planning, Architectural and Construction Activities of Georgia (legality of the construction of an individual residential house and auxiliary buildings built without permission and/or in violation of the project) was formed with a new edition.

Law, except section 11 of the first article of this Law, sub-paragraphs "a" - "d" and "f" of Section 12, sections 14-16, sub-paragraphs "a" and "b.b" of section 17 of this Law ", sections 18-20 and sub-paragraphs "c" and "d" of section 23, came into force immediately after publication.

Sub-paragraphs "c" and "d" of part 23, Article 1 of the Law came into force from the 1st of January, 2024.

Section 11 of Article 1 of the Law, sub-paragraphs "a" - "d" and "f" of section 12, sections 14-16, sub-paragraphs "a" and "b.b" of section 17 and sections 18-20 came into effect on the 30th day after publication.

Order №996 of the Minister of Finance of Georgia

On the 5th of December, 2023 an amendment was made to the Order №996 of the Minister of Finance of Georgia by Order №465 of the Minister of Finance of Georgia "on Administration of Taxes and Article 14 of the instruction (distribution of the document to the public) was approved with a new redaction.

Order Nº001 of the Director of the Legal Entity under Public Law - Pension Agency

On the 25th of December, 2023 the following amendments were made in the instruction approved by order №001 of the director of the legal entity under public law - pension agency "on approving the rules for withdrawing from the funded pension scheme, returning pension contributions and investment and/or other income related to these contributions and rejoining:

- 1. The first paragraph of Article 3 was formed in the following way.
- "1. An employee who reached 40 years before the law entry into force (24:00 on August 6, 2018) and does not want to be a participant in the pension scheme, is entitled, with a mandatory manner in the pension scheme, from the date of automatically joining within 5 (five) months but no earlier than 3 (three) months from the date of joining, to withdraw from the pension scheme in accordance with this rule.
 - 2. Article 8¹ was formed with the following redaction:
- "1. After withdrawing from the Funded Pension Scheme, the employee's individual pension page is not cancelled, however it becomes inactive and the employee retains access to the individual pension page.
- 2. The employee who left the pension scheme and also the pension agency is entitled to use the individual pension page for communication purposes.
 - 3. Article 9:
 - a) Paragraph 2 was formed as follows:
- "2. After leaving the pension scheme, in case of re-joining, the employee shall be considered to have joined the pension scheme in a mandatory manner and will not be entitled to leave the pension scheme again.";
 - b) Paragraphs 3 and 4 with the following content were supplemented after paragraph 2:

- "3. The employee, in case of re-joining the pension scheme, is obliged to inform all his employers about this.
- 4. For an employee rejoining the pension scheme, the first pension contribution by his employer will result the creation of an information record about this employee in the electronic system, which will confirm the fact of the employee rejoining the funded pension scheme and will create the basis for activating the individual pension account of the rejoined employee."
