The present newsletter contains significant legislative amendments made in various legislative and sub-legislative acts in May 2024.

Law of Georgia "on Licenses and Permits"

On the 15th of May, 2024 the following amendment was made to the Law of Georgia "on Licenses and Permits":

- 1. Paragraph 5 of Article 91 was formed with the following redaction:
- "5. The technical safety norms of the building-structure provided in subparagraph "e" of paragraph 3 of this article and the authorized person issuing the document confirming compliance with the technical safety norms of the building-structure is determined by the technical regulations stipulated by the first paragraph of Article 15 and the first paragraph of Article 17 of the Law of Georgia "on Weapons".
 - 2. Article 22² with the following content was supplemented to the law:

Article 22². Revoking licenses for activities provided in paragraphs 10¹-11² of Article 6 of this law due to non-compliance with the amended license conditions

- 1. The owners of licenses for activities provided in paragraphs 10¹-11² of Article 6 of this law (including the license provided for in paragraph 2 of Article 38 of this law) are obliged to ensure compliance with the amended license conditions no later than 1 year after the amendment of these conditions.
- 2. Holders of licenses for the activities specified in the first paragraph of this article are obliged to submit documentation confirming compliance with the amended license conditions to the license issuer in writing no later than 5 calendar days after the expiration of the term provided in the same paragraph.
 - 3. License issuer:
- a) declares the license invalid within 7 calendar days, if the license holder has not submitted the documentation confirming compliance with the amended license conditions in accordance with the procedure established by paragraph 2 of this article;
- b) within a period of 30 calendar days reviews the documentation confirming compliance with the amended license conditions submitted by the license holder and makes a written decision:
- b.a) about declaring the license invalid, if compliance with the amended license conditions is not confirmed by the mentioned documentation;
 - b.b) Regarding compliance with the amended license terms.
- 4. The license issuer takes the decision specified by this article according to the simple administrative procedure established by the General Administrative Code of Georgia."

Law of Georgia on Maritime Code of Georgia

On the 15th of May, 2024 Parts 5152 of Article 70 of the Maritime Code of Georgia (Sea Port) and Article 78¹ (Definition of Terms) were formed with a new redaction.

The first article of the Law will come into force from the 1st of October, 2024.

Law of Georgia "on Facilitating the Prevention of Money Laundering and Financing of Terrorism"

On the 30th of May, 2024 an amendment was made to the Lae of Georgia "on Facilitating the Prevention of Money Laundering and Financing of Terrorism" and Article 2 (Definition of Terms); Article 3 (Disabled Persons) of the Law etc. were formed by a new redaction.

The Law, except for sub-paragraph 'b' of paragraph 2, Article 1 and paragraphs 4, 9, and 11 of this Law, came into force upon publication."

"Sub-paragraph b of paragraph 2 and paragraphs 4, 9, and 11 of Article 1 of the Law will come into force on from the 1st of December, 2024."

"Order № 002 of the Director of the Pension Agency made on the 30th of July, 2019."

On the 1st of May, 2024 by the order No13 of the director of the legal entity under public law - Pension Agency the following amendment was made in order №002 of the director of the legal entity under public law - Pension Agency made on the 30th of July, 2019 regarding the approval of the instructions on the rules for the payment of pension contributions, the forms of information submission, the administration of overpaid amounts, the accrual of pension contributions, expense, surplus income, loss, other income, surpluses and losses to the individual pension account":

- 1. Paragraph 7¹ of Article 4 was formed with the following redaction:
- "71. Except for registration/authorization through the username and temporary password specified in paragraph 5 of this article, the employee/pension recipient is entitled to register/authorize in the electronic system of administration of pension contributions

through the electronic identity card (ID card) or electronic residence card of a citizen of Georgia or by any other means available in the electronic system (if any).

- 2. Article 5² was supplemented after Article 5¹ with the following content:
- "5². Providing access to the electronic system
- 1. The pension agency is authorized to sign a contract/agreement/memorandum with the third party(ies) for the purpose of informing the participants/pension recipients, to provide alternative means of accessing the employee's pension page, in addition to the provisions of this instruction, in order to receive the relevant services.
- 2. For the purposes of this article, the relevant service provider is authorized to process personal data only to ensure the opportunity provided in the first paragraph of this article."

Sub paragraphs "a" and "b.a" of paragraph 2, the first article of this order came into force immediately after publication and their effect was extended to legal relationships arising from the 1st of January, 2024.

In the same order, on the 27th of May, 2024 by order №169 of the Minister of Finance of Georgia, an amendment was made and the title of Chapter XVI3 was formed with the following redaction: Chapter XVI3. Taxable operation implementation place " and Article 66⁶ (Services related to immovable property).
